

Why are US tariffs on solar panels coming to Southeast Asia?

Nov 29 (Reuters) - U.S. trade officials announced on Friday a new round of tariffs on solar panel imports from four Southeast Asian nations after American manufacturers complained that companies there are flooding the market with unfairly cheap goods.

Are Southeast Asian solar panels being used as tariff proxies?

world war fee Solar panels made in a number of Southeast Asian countries face massive new import duties into America, some as steep as 3,521 percent, after a US Department of Commerce probe apparently found the countries were being used as tariff-dodging proxies for Chinese state-subsidized manufacturers.

Where do US solar cells come from?

At issue are imports of crystalline silicon photovoltaic cells — and modules made with them — from Cambodia, Malaysia, Thailand and Vietnam, countries which provide the bulk of US supply of that equipment today. Those nations provide the bulk of US solar cell and module imports.

Are solar imports from Southeast Asia unfairly benefiting from government aid?

Those nations provide the bulk of US solar cell and module imports. The announcement comes nearly two months after the US agency issued preliminary findings from a separate but related probe that the solar imports from Southeast Asia are unfairly benefiting from government aid.

Are Chinese solar companies working in Southeast Asia to avoid tariffs?

This investigation started after a petition from a group of U.S. manufacturers, known as the American Alliance for Solar Manufacturing Trade Committee, was filed in April 2024. The group claimed that primarily Chinese solar




companies were working in Southeast Asia to avoid paying existing tariffs on Chinese goods.


