Is it illegal to buy or sell a house with solar energy?

First, by making it illegal for any property to be bought and sold if the agreement prohibits the installation or use of any solar energy device. This law was enacted in 1979 and remains enforced today. Another notable law is to remove any rights of HOAs to prohibit the installation of solar energy devices.

Are solar panels a viable option?

However, some states still make installing solar panels functionally impossible by creating laws with "reasonable restrictions," such as increased taxing, energy caps, or even billing solar panel users. Combine these laws with a lack of incentive programs, and solar panels are not viable for homeowners in many states.

Is solar energy legal in California?

Most of California's solar energy regulations can be found in California's Solar Rights Act of 1978. As a start, it also makes it illegal for any property to be



bought and sold if the agreement prohibits installing or using any solar energy device.
