

# Poland integrated base station communication tower







#### **Overview**

How many ontower sites are there in Poland?

OnTower Poland currently operates a total of 8,500 sites in Poland and plans to deploy up to c. 3,400 new sites up to 2030, and has a 20-year service provision contract with Play, extendable for additional successive 10-year periods. About Cellnex Telecom.

Why did Cellnex buy Polkomtel Infrastruktura?

Indeed, in October 2020, Cellnex partnered with Iliad in a €2.6bn deal, to acquire 7.0k towers from wireless carrier Play in Poland. Secondly, the Polkomtel Infrastruktura deal exemplifies Cellnex's shift in strategy from simply the traditional tower operator model. Indeed, the company is now pursuing an infrastructure management model.

Who owns ontower Poland?

Barcelona – Warsaw, 30 June 2023. Iliad has today sold its current stake (30%) in OnTower Poland, the Polish telecommunications infrastructure company controlled by Cellnex (which holds 70%). The company was set up by both operators in 2021 as part of Cellnex's acquisition of the network of c. 7,000 sites from mobile operator Play in Poland.

How many sites does Cellnex manage in Poland?

With the integration of OnTower Poland, Cellnex now boasts a formidable footprint of around 15,500 sites in Poland. This forms a significant part of the approximately 135,000 sites Cellnex manages across Europe, underscoring the company's position as a major player in the European telecommunications infrastructure sector.

Who owns Polkomtel Infrastruktura?

Cellnex Telecom today announced an agreement with Cyfrowy Polsat to acquire its digital infrastructure subsidiary Polkomtel Infrastruktura, which



owns 7.0k towers in Poland, for €1.58bn. Additionally, the transaction includes a build-to-suit (BTS) program of up to 1.5k tower sites over the next 10 years with an investment of €0.6bn.

What is Polkomtel Infrastruktura's tenancy ratio?

Polkomtel Infrastruktura's 7.0k tower sites in Poland have a tenancy ratio of 1.2x. Indeed, this equates to 8.4k tenants with equipment on the company's towers. From a physical standpoint, 55% of the towers are ground-based and 45% are rooftop sites.


