

Public communication base station inverter power generation certification





Overview

Do inverters need a dedicated communications port?

Inverters certified to IEEE1547-2018 are required to have a dedicated communications port for the local utility. The Company may require the use of that port for monitoring and/or control of DERs as more advanced grid management systems are introduced.

What is an inverter certification test?

The inverter certification tests must also provide data to show maximum power tracking effectiveness, efficiency variations associated with power line voltage, environmental effects, and losses that occur at night and during protective shutdowns.

Can a certified inverter interfere with a customer's generating equipment?

The interconnection of the Customer's generating equipment with the Company's system shall not cause any significant reduction in the quality of service being provided to other customers. Certified inverters, unless they are malfunctioning or misapplied, will generally comply with the Section 3 requirements.

Are smart inverters a viable alternative to system upgrades?

The Company may implement smart inverter settings for interconnections as a potential alternative to system upgrades for interconnection mitigations. Some inverters will accommodate programming upgrades to become compliant with the advanced certification. Upgrading to certified smart inverter status when it becomes available is desirable.

What are the requirements for a power inverter?

Inverter should meet the requirements specified in IEEE Std. 929-2000 or other national standard or the interconnecting utility requirements. Phase current imbalance should be less than 5% measured at 50% and 100% rating.



Unbalanced phase currents may cause overheating of the utility transformer.

Do inverters provide a ground source?

There are only two types of sources, from a transformer with the suitable configuration or a grounded wye rotating machine. Inverters do not provide a ground source but they may have interface transformers that can provide this source. The power transformer configurations that can provide a zero sequence source are identified below.

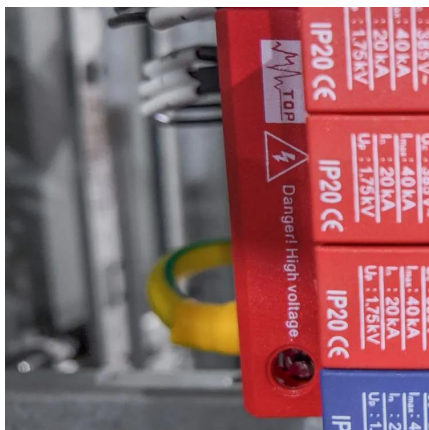

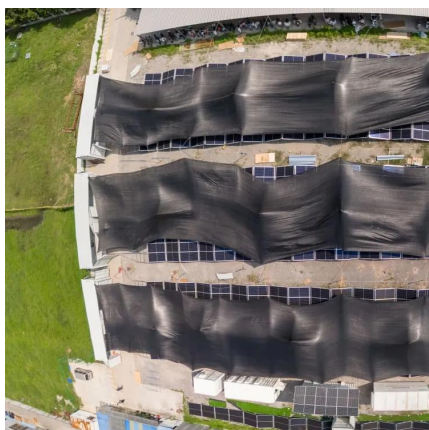
