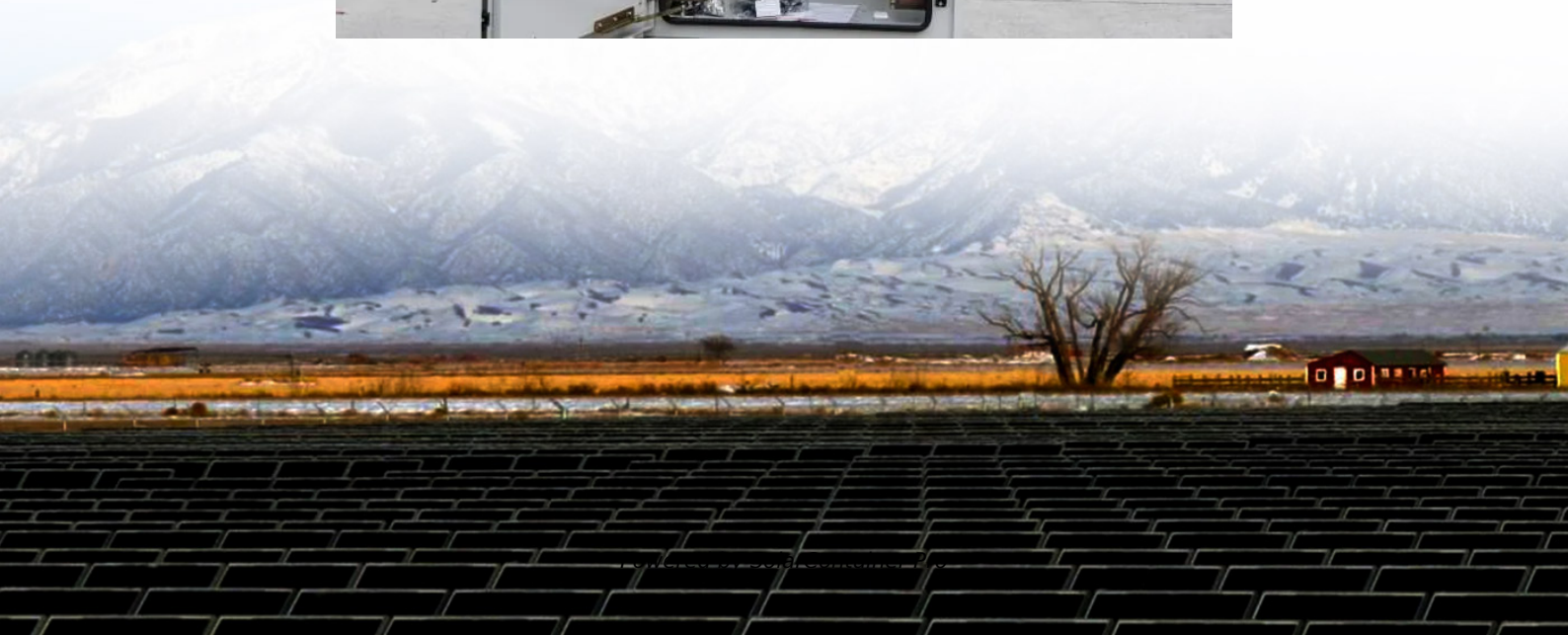


Solar inverter subsidies

Are solar panels eligible for the federal solar tax credit?

Can I get a tax credit if I switch to solar?

What grants are available for solar panels?

1. Green Retrofit Solar Panel Grants Note: Funds must be used within 2 years of receiving them. 2. High Energy Cost Grants Extra tip: You must prove your area's average energy cost exceeds 275% of the national average. 3. Weatherization Assistance Program (WAP) 4. Low-Income Home Energy Assistance Program (LIHEAP).

Do you owe taxes on solar energy?

The amount of tax credit varies by state. State government rebates for solar energy are typically a set amount of money given to those who purchase a solar system or other qualifying solar technology (e.g. solar water heaters and solar batteries). These are typically available regardless of whether or not the homeowner owes any federal taxes.
