Should St Kitts and Nevis be connected?

"With geothermal, it justifies interconnecting the two islands. St. Kitts and Nevis then becomes one electrical grid, so any industry developed on St. Kitts or Nevis will be able to share any renewable energy resource on either island," explained Minister Maynard.

What does a unified energy grid mean for St Kitts and Nevis?

The unified grid represents a physical manifestation of the political collaboration now taking place between the federal government and the Nevis Island Administration. Perhaps the most ambitious aspect of St. Kitts and Nevis' energy vision is the potential to move beyond self-sufficiency to become a net energy exporter to neighboring islands.

How does the government of St Kitts and Nevis work?

The government of St. Kitts and Nevis provides a legal framework to foster competition and establish clear rules for foreign and domestic investors in the areas of tax, labor, environment, health, and safety. The Ministry of Finance and SKIPA provide oversight of the system's transparency as it relates to investment.


